

NHS South Yorkshire ICB Medicines Optimisation Quality Improvement/Incentive Scheme QIPP Reviews Supporting Information

QIPP reviews form part of component C within the Medicines Optimisation Quality Improvement/Incentive Scheme 2026-27. Practices are required to review a selection of medicines identified within the South Yorkshire ICB QIPP work programme as suitable for switching to lower cost alternative formulations or products, in line with the requirements of the scheme.

Decision support software (OptimiseRx) will be updated, where applicable, to support these switches by prompting prescribers within clinical systems.

Patients prescribed the identified medication should be reviewed, and where clinically appropriate, offered a change in therapy.
